Testing was conducted in accordance with the **eRAD RIS TEST PLAN FOR CURES REAL WORLD TESTING**.

## Test Target

### Care Settings to be Tested

Each CHPL listing requires a Test Plan with corresponding test results derived from testing performed in a representative "Setting of Care" for which the product is marketed (intended for use).

As the eRAD RIS Version 4 Enterprise Radiology Solution is marketed for use as an Ambulatory Radiology solution and is listed as a single module in the Certified Health IT Product Listing (CHPL). This single Test Plan encompasses the full scope of testing of our solution in a single setting of care which is "Ambulatory Radiology".

### System Under Test

Testing was performed using **eRAD RIS VERSION 4.2025.036, 4.2025.056, 4.2025.060, and 4.2025.063** software.

While the test scope includes all available functionality that is marketed to this care setting, at this time a significant portion of this functionality is not currently in use by customers and as a result execution of workflows was performed in a test (non-production) environment.
